



## **CUFF PENETRATION LIMITED PRODUCT WARRANTY**

This limited warranty constitutes our responsibility and obligation to repair and/or replace materials or components. We make no other express or implied warranties or any warranty of merchantability or fitness for a particular use except for the limited conditional warranty stated below.

### **1. CONDITIONS OF WARRANTY**

This warranty applies only to materials and components manufactured by Western Fiberglass, Inc., and are subject to notifications by the original customer within 24 hours of the first discovery of each cause, effect or occurrence which may cause any claim under this limited warranty, further:

- A. The components manufactured by Western Fiberglass, Inc. be used only for the purpose for which they were designed, intended, and installed, further:
- B. That the use of said components be for the normal uses, service conditions and installations approved by Western Fiberglass, Inc.

### **2. LIMITED WARRANTY**

Subject to the conditions herein, Western Fiberglass, Inc. warrants, for the period and conditions below, that components manufactured by Western Fiberglass, Inc.

- A. Will conform to manufacturer's specifications at the time of sale and will be free from defects in materials and workmanship for five (5) years from date of original purchase.
- B. Will not fail due to external corrosion for a period of five (5) years.
- C. Will not fail due to internal corrosion in any application designed and used for containment of materials specified upon original order for the same period, as described in paragraph B., in section 2 above.

### **3. RESPONSIBILITIES OF USER**

- A. Contractor and/or End User is responsible for removal and replacement, in a timely manner, of any and all fuel dispensing equipment required to be removed to provide Western Fiberglass's technicians with unrestricted access to the Cuff and the Cuff accessories. This may include, but is not limited to, removal of the dispenser(s).
- B. Contractor and/or End User is responsible for any and all fee's, permits and any associated approvals required to find, diagnose and complete the repairs. Contractor/End User agrees that Western Fiberglass is not responsible for costs required to find and diagnose the defect or problem.
- C. Contractor and/or End User agrees to be responsible for all fees and costs if the defect or problem is not caused by Western Fiberglass's Cuff or is the direct result of incorrect installation or application.
- D. Contractor and/or End User are responsible for travel cost and per diem for Western Fiberglass' technicians outside of the continental United States.

### **4. RESPONSIBILITIES OF WESTERN FIBERGLASS**

- A. For a period of five (5) years from date of original purchase, Western Fiberglass will provide materials at no cost to the End User, to repair or replace any defective Western Fiberglass Cuff provided the User Responsibilities described above are adhered to.
- B. Western Fiberglass, Inc. assumes no responsibility for down time, loss of business, fees or fines or any other items except as outline in item A and B in paragraph 4.
